**PERSONAL PROPERTY ASSESSMENT AND CANVASS PROCEDURES
PER: 211.8 & 211.9 & 211.22 & 211.24**

The assessor shall follow all State of Michigan procedures, rules, regulations, and administrative procedures when creating, placing, or altering a personal property assessment for all assessable personal property.

The assessor shall send a notice of assessment to the last known mailing address of every suspected business in the assessment jurisdiction annually as required by law.

The assessor shall, when necessary, send an estimate of value to every business in its jurisdiction when an annual statement is not filed. This estimate shall be based on the assessor's best judgement and where possible, research the probable value of the assessable equipment in the development of this estimate.

The assessor shall personally review every personal property statement received annually.

If the assessor believes any filed personal property statement is not accurate, the assessor shall do one of or all the following: 1) Contact the owner and discuss possible changes. 2) Estimate the value of the businesses assessable property using on-line, local costs estimates or other reliable sources to best estimate the assessable personal property. 3) Request from owner their documentation of original costs.

The assessor shall perform a Tax Day Canvass of the jurisdiction for new personal property. This canvass shall include the discovery of machinery, equipment etc. found in its jurisdiction. This Tax Day Canvass is primarily equipment used at construction sites and is not licensed to be driven on the roads of Michigan. If the assessor finds Tax Situs equipment and places a value on the current assessment roll, the assessor shall flag this parcel to perform an on site inspection to determine if the equipment is now removed; and if it has been removed; change the value for the next year to zero as to not assess property that has been properly removed for assessment purposes. This canvass shall include, as much as possible, photographs of said assessable equipment, identifying marks for each piece of equipment such as: serial numbers, the owners identifying numbers, markings, and codes etc. as proof of each assessable item. The assessor shall insure that each photo has a date of its existence as being on site within the jurisdiction as of 12-31 of each year.

If the assessor believes the owner of the equipment has intentionally removed the equipment to another location/jurisdiction simply to avoid being locally assessed, as per MCL 211.22 & 211.24. The assessor shall document the location by address, photograph etc. and make an estimate of value and place it on the assessment roll. CAUTION IS ADVISED if this situation arises, the assessor shall confirm with the assessor of that jurisdiction to ensure

The assessor shall work professionally with each property owner and follow all laws of the State of Michigan to ensure a fair and accurate assessment of any assessable personal property in its jurisdiction.
